Code of Conduct for Members

As a member or co-opted voting member I have set out below the **Disclosable Pecuniary Interests** (Part A) and the **Other Registrable Interests** (Part B) and Gifts and Hospitality (Part C) which I am required to disclose under the council's Code of Conduct for members and co-opted voting members, and I have put "none" where I have no such interests under any heading.

"Disclosable Pecuniary Interest" means an interest of yourself, or of your partner if you are aware of your partner's interest, within the descriptions set out in Part A of the Table below.

"Partner" means a spouse or civil partner, or a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners.

Other Registrable Interest means an interest as set out within the descriptions set out in Part B of the Table below.

NOTE: Members and co-opted members must register Disclosable Pecuniary Interests and Other Interests with South Gloucestershire Council's Monitoring Officer within 28 days of the election to office.

² 'securities' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

³ 'Land' excludes an easement, servitude, interest or right in or over land which does not give the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/ civil partners (alone or jointly with another) a right to occupy or to receive income.

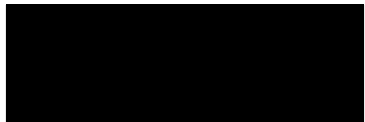

	You must register as an Other Registerable Interest: a) any unpaid directorships b) any body of which you are a member or are in a position of general control or management and to which you are nominated or appointed by your authority c) any body (i) exercising functions of a public nature (ii) directed to charitable purposes or (iii) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union) of which you are a member or in a position of general control or management.
