#### Questions and comments from members of the public.

If you are recording the meetings, you are asked to act in a reasonable manner and not disrupt the conduct of repeat statements for the benefit of the recording. You may not make an oral commentary during the meeting. The Chair has the power to control public recording and/or reporting so it does not disrupt the meeting. Recording must be clearly visible to anyone at the meeting.
