# SOUTH GLOUCESTERSHIRE COUNCIL (OFF STREET PARKING PLACES) ORDER 202(-)

The District Council of South Gloucestershire (hereinafter referred to as "the Council") in exercise of its powers under sections 32, 33 and 35 of and Part IV to Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") the relevant powers under Part 6 of the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") and The Civil Enforcement of Parking Contraventions (Guidelines on level of charges) (England) Order 2007 and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following order:-

#### PART I - GENERAL

#### Commencement and Citation

1. This order shall come into operation on the and may be cited as the South Gloucestershire Council (Off Street Parking Places) Order 202(-).

#### Interpretation

- 2. (1) Any reference in this order to a numbered Article is a reference to the Article bearing that number in this order.
  - (2) In this order:-

"**bank holiday**" has the same meaning as defined in the Banking and Financial Dealings Act 1971;

"**car club**" means a car club or similar organisation (including any person or organisation acting on behalf of such club or organisation) approved in writing by the Council for the purposes of this order;

"car club vehicle " means a vehicle of a type approved by the Council and provided by a car club or by the Council for the use of persons who have paid any relevant membership or other car club fee and by means of a real-time or advance booking system may have use of the vehicle for a specified period and which displays the relevant identification issued and/or approved by the Council;

"charge point" has the same meaning as in section 9 of the Automated and Electric Vehicles Act 2018;

**"charging hours"** means any period in respect of which a charge is specified in Article 6;

"**civil enforcement officer**" means a person authorised by the Council to act as a "civil enforcement officer" as defined in section 76 of the Traffic Management Act 2004;

"**disabled person's badge**" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 2000 as amended;

"disabled person's parking place" means an area in the car park reserved solely for the parking of a disabled person's vehicle;

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 as amended;

"**driver**" in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place

"electric vehicle" means a motor vehicle that is powered entirely or partially by electricity and is capable of being charged from an external source;

"electric vehicle parking bay" means an area of the parking place provided solely for recharging the battery of an electric vehicle by means of a charge point and indicated by means of a sign, surface marking or other indication;

"**invalid carriage**" and "**motor cycle**" have the same meaning as in section 136 of the Act of 1984;

"motor car" and "motor vehicle" means a mechanically propelled vehicle not being a motor cycle or an invalid carriage which is constructed itself to carry a load or not more than seven passengers exclusive of the driver and their effects, is fitted with tyres of such a type as may be specified in regulations by the Secretary of State and of which the weight unladen does not exceed 3000 kilograms;

"owner" has the same meaning as in section 92 of the Act of 2004;

"**parking bay**" means any area of a parking place which is provided for the leaving of a vehicle and indicated by markings on the surface of the parking place;

**"parking place**" means any area of land specified by name in column 1 of Schedule 1 or column 1 of Schedule 2, provided by the Council under section 32 or section 33 of the Act of 1984 for use as a parking place;

**"pedal cycle**" means a bicycle, tricycle or cycle having four or more wheels, not being in any case a motor vehicle;

"penalty charge" and "reduced penalty charge" means a charge set out by the council under the provisions respectively of Sections 72 and 77 and of Schedule 9 of the Act of 2004 in accordance with guidance given by the Secretary of State for Transport which is to be paid in the manner described in the Penalty Charge Notice within 28 days of the date of the notice or 14 days (21 days if imposed on the basis of a record produced by and approved device) of the date of the notice in the case of a reduced penalty charge;

"**penalty charge notice**" means a notice issued by a civil enforcement officer pursuant to the provisions of Section 78 of the Act of 2004 in respect of a contravention which is subject to civil enforcement under the provisions of Section 73 and of Schedule 7 to the said Act;

"**prescribed**" means prescribed by any enactment or any regulation, order, direction or other instrument made thereunder;

**"public service vehicle**" has the same meaning as in section 1(1)(a) of the Public Passenger Vehicle Act 1981;

**"relevant position**" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 as amended;

"**season ticket**" means an electronic or paper ticket purchased in advance subject to certain conditions for the period and parking place specified;

**"trailer**" means a vehicle drawn by a motor car as defined in section 136 of the Act of 1984; and

"validated parking session" means a virtual parking session exempting the driver for the charges valid for a specific purpose under the authority of South Gloucestershire Council.

- (3) The Interpretation Act 1978 shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament and as if for the purposes of section 16 of that Act this order were an Act of Parliament and the orders revoked by Article 10 of this order were an Act of Parliament thereby repealed.
- (4) Any reference in this order to any enactment shall be construed as a reference to that enactment as amended applied consolidated or re-enacted by or having effect by virtue of any subsequent enactment.

#### PART II - USE OF PARKING PLACES

- 3. (1) Each area of land specified by name in column 1 of the Schedule to this order may be used, subject to the following provisions of this order, as a parking place for such classes of vehicles, in such positions on such days and during such hours as are specified in relation to that area in the said Schedule.
  - (2) Where in the Schedule to this order a parking place is described as available for vehicles of a specified class or in a specified position the driver of a vehicle shall not permit it to wait in that parking place unless it is of the class and in the position so specified.
  - (3) The driver of a vehicle shall not permit it to wait in the parking place specified in column 1 of the Schedule to this order for longer than the maximum period of waiting specified in column 6 of the said Schedule.
  - (4) When a vehicle has left a parking place, the driver of that vehicle shall not permit said vehicle to return to the parking place within the no return time period specified in column 6 of the Schedule to this order.
  - (5) Nothing in paragraph (1) or paragraph (2) or paragraph (3) or paragraph (4) of this Article shall apply to any vehicle which is a vehicle in the service of or employed by the Council and is being used for the purpose of cleaning or carrying out maintenance works in the parking place.
  - (6) No vehicle, other than an electric vehicle which is connected via a connecting lead to a charge point and charging shall be left in any electric vehicle parking place.
- 4. (1) Where, within a parking place, there is a sign or surface marking which indicates that a parking place is available only for a disabled person's vehicle, the driver of

a vehicle shall not permit it to wait in that parking bay unless it is a disabled person's vehicle or an invalid carriage. A valid disabled person's badge must be displayed in the relevant position on any vehicle parked within those places and must remain so displayed until such time as the vehicle leaves that parking place.

- (2) Where, within a parking place, an area is marked as reserved for a specified class of vehicle, no vehicle of any other class shall wait in any such area unless as may be required by a civil enforcement officer or an employee of the council or its representative on duty at the parking place.
- (3) Where, within a parking place, an area is marked as reserved for special functions or otherwise not available for general use, no vehicle shall wait in any such area unless as may be required by a civil enforcement officer or an employee of the council or its representative on duty at the parking place.
- (4) In so far as a vehicle is left in a parking place during the charging hours the driver thereof shall pay such charge or charges as are specified in the following provisions of this order.
- 5. (1) Nothing in this order shall prevent the Council, by notice displayed at the parking place
  - a. from closing the parking place or any part thereof for any period; or
  - b. from setting aside for use only by specially authorised vehicles of any part or parts of the parking place on all days or on certain days or during certain parts of certain days.
  - (2) Nothing in this order shall prevent any person specially authorised by the Council from using any parking place or part thereof as may be defined by the Council -

Provided that any such use is in accordance with any conditions or restrictions contained in any such authorisation and is only for the duration specified in therein.

#### PART 3 - CHARGING PROVISIONS

#### Payment for use of parking place

- 6. (1) This Article applies to those parking places specified by name in column 1 of the Schedule in relation to which a charge is imposed by column 7 and column 8 of the said Schedule.
  - (2) The parking charge for a vehicle left in a parking place during the charging hours shall be as set out in relation to that parking place in column 7 and column 8 of the Schedule.
  - (3) The driver of the vehicle shall immediately upon first parking, pay the appropriate parking charge in accordance with the scale of charges referred to in column 7 of the Schedule.
  - (4) Where the council has a validation scheme in place the driver will ensure that their vehicle is registered within 10 minutes of arrival at the parking place.

- (5) Where specified in the schedule at each parking place where season tickets are permitted the holder of such will be exempted from the parking charge provided that the vehicle registration has been provided for that session.
- (6) The charge referred to in paragraph (2) of this Article shall be payable by either:-
  - (a) the insertion of an appropriate credit or debit card into the apparatus or device provided being apparatus or device approved in accordance with section 35(3) of the Act of 1984 and the provisions of section 47(5) of the Act of 1984 apply in respect of such apparatus; or
  - (b) where provision is so made, by Telephone Payment, or online, or app or by text message; or
  - (c) where provision is made for use of a credit or debit card, or contactless payment, by such method.
- (7) Reference to electronic proof of purchase will be the means of confirming compliance with the provisions of this order with regards to the payment of parking charges.
- (8) The owner of a vehicle may on application to the Council purchase a season ticket, subject to availability, in respect of that vehicle for a parking charge ascertained by reference to the charge specified in paragraph (2) of this Article and that season ticket shall be valid in such parking places as are specified thereon during the period for which it is issued.
- (9) Any physical permit or ticket issued shall be attached in a conspicuous position to the vehicle in respect of which it was issued.

# Contravention of order - Penalty Charge

- 7. (1) If a vehicle is left in a parking place on any day in contravention of or noncompliance with any provision of this order, a Penalty Charge shall be payable by the owner of that vehicle.
  - (2) When a Penalty Charge Notice has been attached to a vehicle it shall not be removed or interfered with except by or under the authority of:-
    - (a) the owner of the vehicle or the person in charge of it, or
    - (b) a Civil Enforcement Officer or other person duly authorised by the Council.
  - (3) A vehicle which has incurred a Penalty Charge and which, having not since been moved, remains parked in contravention of the parking regulations, will not incur any further Penalty Charges until a period of 24 hours has elapsed from the time at which the first Penalty Charge Notice was issued to it.

#### Representations and Appeals

- 8. The Civil Enforcement of Parking Contraventions (England) Representations and Appeals Regulations 2008 as amended shall apply in relation to this order in respect of the making and determination of representations and appeals.
- 9. The Council accepts no liability for loss or damage to vehicles or the property left in any of the Council's parking places to which this order applies.

#### PART V - REVOCATIONS

10. The South Gloucestershire Council (Off Street Parking Places) Order 2022 and the South Gloucestershire Council (Off Street Parking Places) (Kings Chase Shopping Centre Car Park) (Variation No. 1) Order 2023 are hereby revoked.
